1.0 scope

And Course Brochure will be provided by Second Party
- 1.3 The First Party agrees for sponsoring and shall provide Advertising, Marketing , Bidding , Course Registration, Venue selection / arrangements , administrative support as necessary and also to provide Visa for Sanjary faculties including Accommodation & Transportation as and when required.
- 1.4 The First Party shall invite Second Party for conducting Certification Courses (Document No.) in.....USA , Singapore , Dubai , Saudi Arabia , Qatar etc. as when required with Minimum of Engineers / Students / Trainees.
